- **Development:** Educational process is a raising awareness and understanding of the rapidly changing, interdependent and unequal world in which we live. For the program to be effective, meet the needs of participants. You need to set goals.
- Determine content
- Select a participant
- Set a schedule
- Select a facility
- Choose a teacher

### Program Coordination Development Program
